Year-Round Event Coordinator's Report - Gloria Pratt has begun the renewal process of our 18 YRE's. Gloria is also looking for a volunteer to be our "point of contact" for our seasonal Blue Springs Park walk. She is also looking for a new "home" for the Sanford walk box since the Marina is not working out. Also, a reminder - the Savannah walk box is now online only.
