AVA Special Programs: Walks: Little Free Libraries; Bike Ride: Rails to Trails Walking the USA, A-Z (T) Continues through December 2022 for current participants ONLY: for both.

AVA TRAIL RATING: Walks: 1A Paved paths within the park, mostly flat, with a few small foot bridges.

Bike Rides: 1A. Sidewalks in/out of the park connecting to the Florida Coast-to-Coast Rail Trail system.

DESCRIPTION: Wander through the scenic Chain of Lakes Park for a 5k or 10k walk, with abundant Florida wildlife and a viewing tower for vistas to Cape Canaveral. Or, set out on a bike ride around the park and then north on the Florida Coast-to-Coast rail trail to Mims and back. Ride 1 hr. (~13km) or 2 hours (25km) during the bike event. Afterwards, join club members for a BBQ picnic at the start/finish.

PARTICIPATION: These are non-competitive, fun events for all persons. People of all ages are welcome to participate. An adult must accompany all minors on this event.

DISCLAIMER: The American Volkssport Association or its subsidiary clubs are not responsible for theft or loss of personal belongings or property.

REGISTRATION: Register between 8:30 a.m. and 10:30 a.m. Bike rides are in a group with a lead and trail rider, at between 8 – 12 mph. The walks are at your own pace. We provide detailed walk instructions, a map, and a start number. Participants walk at their own pace, normally taking about 1 hour for 3 miles (5 kilometers) and 2-2.5 hours for 6.2 miles (10 kilometers). The completion time is prior to 1 pm. Please check-in at the finish when you return to stamp your books and turn in your start card, so we know you have completed the event.

COSTS: There is a \$3 fee covering administrative costs for the event and for the AVA/IVV event stamp used to sanction/record the event. No refunds are provided after the start of the events.

FOOD and WATER: Water and hard candy are available at the start point and any checkpoints. Carry your own drinking water.

A picnic will be provided by members of the Happy Wanderers – with main course of hamburgers / hotdogs provide by the club, and a member's sign-ups for side dishes, drinks & desserts on the club website.

AWARDS: No awards for these events, but IVV event & distance credit (stamps) will be available.

SANCTIONED: This event is sanctioned by the American Volkssport Association (AVA), a 501c. (3) non-profit and member of the International Federation of Popular Sports (IVV).

DIRECTIONS (for GPS Navigation):

2300 Truman Scarborough Way, Titusville, FL 32796

HW/FCWC – From I-95 S, take Exit 223 to FL-46 (West Main St.) for 3.8 miles to US 1. Turn **RIGHT** and go 1.9 miles to Truman Scarborough Way. **TURN LEFT** and follow to the park entrance. **TURN RIGHT** inside the park on Snowy Egret Dr, to the pavilion (look for Walk Start signs)

MFM – From Orlando, use FL 408 E to FL 50 to I-95, then north on I-95 to Exit 220. Drive 1.7m to N. Singleton. **TURN LEFT** for .9m to Dairy Rd. **TURN RIGHT** on Dairy to US1, continue straight across onto Truman Scarborough, to park entrance. *Follow directions above from there.*
